Product Description

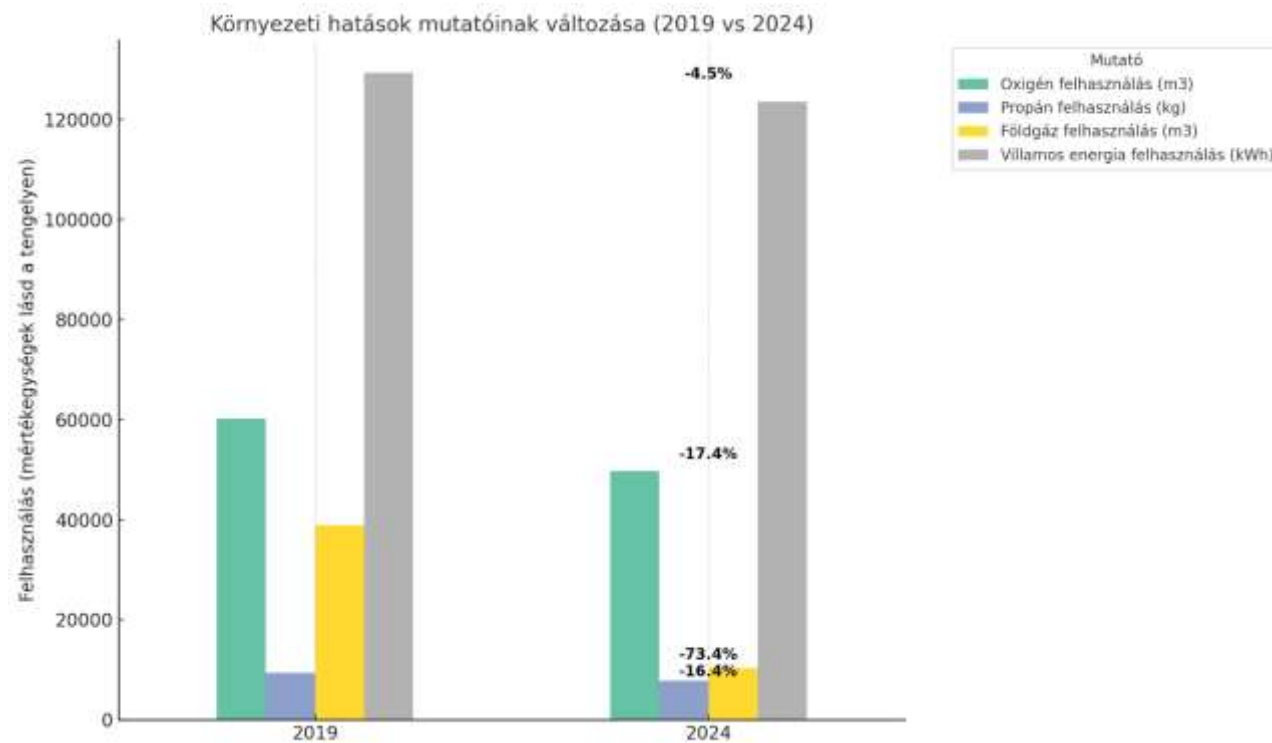
Acélpartner Ltd. was established on 22 March 1999. The company operates one of Hungary's leading thermal cutting facilities at its privately owned industrial site located at 76–80 Gyömrői Road, District X, Budapest, on the premises of the former Budapest Chemical Machinery Plant. Over the past 25 years, the company has specialized in metal processing, including machine flame cutting and plasma cutting of hot-rolled heavy plates. It also undertakes the complete manufacturing of subassemblies from machined or company-cut and processed components. In cooperation with subcontractors and a subsidiary company, it carries out milling, drilling, and turning operations using CNC machining centers installed at their facilities.

At Acélpartner Ltd., the production of high-quality steel-based products aligns with the company's sustainability objectives. Energy-efficient manufacturing practices are implemented, and environmental responsibility is prioritized throughout all operations.

- Modernization of the electrical network and installation of new compressors.

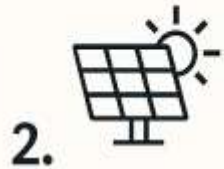
